Where a Member is a subsidiary of a parent company owning a majority interest (more than 50%) in the Member, or the Member is included in the consolidated financial statements of the parent company, the Member must include sales of the parent company in its dues calculation and the parent organization shall be considered to be the Member. If the Member is itself a separate legal entity, then membership must be based on that entity alone, and its dues shall be calculated on its own annual sales revenues.

To qualify for retailer membership, at least 50% of company sales must come from retail operations or the company must specify the technology that must be used in a brand or franchising capacity.
